**EARLY REGISTRATION FOR SCHOOL YEAR 2023-2024**

1. Pursuant to DepEd Order No. 10, s. 2023 and DepEd Order 03, s. 2018, this office announces the conduct of Early Registration for SY 2023-2024 of incoming Kindergarten, Grades 1, 7, and 11 learners in public schools on **May 10 to June 9, 2023**. While incoming Grades 2-6, 8-10, and 12 learners from public schools are considered pre-registered, thus they do not need to participate in the early registration. Private schools are expected to conduct their respective early registration activities in the same timeframe.
2. The following are the objectives of the early registration:
  - 2.1. Ensure that all 5-year old children are enrolled in kindergarten
  - 2.2. Identify, locate and enroll out-of-school children and youth who are geographically in remote and isolated places, those who are in difficult circumstances in terms of belonging to disadvantaged groups and lastly, those who have dropped-out but would like to go back to school.
  - 2.3. Gather data to make necessary preparations and adjustments of plans for the incoming school year.
3. Please find hereunder the following criteria that shall serve as basis for eligibility for enrolment:
  - 3.1. Kinder: 5 years old on or before two months after the opening of class.
  - 3.2. Grade 1: Kinder completer, PEPT Passer for Kinder level, 6 years old and above on or before two months after opening of class, or assessed as Grade 1-ready as per ECD checklist (D.O. No. 47, s. 2016)
  - 3.3. Grade 7: Grade 6 completer, PEPT Passer for Grade 6, or ALS A&E Secondary Passer
  - 3.4. Grade 11: Grade 10 completer, PEPT Passer for Grade 10, or ALS A&E Secondary Passer (2018 or earlier)

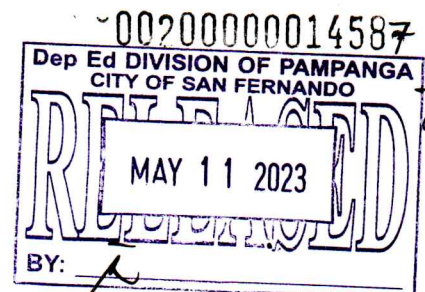

**AMENDMENT TO DEPED ORDER NO. 03, s. 2018**  
(Basic Education Enrollment Policy)

To: Undersecretaries  
Assistant Secretaries

1. The Department of Education (DepEd) issued DepEd Order (DO) No. 03, s. 2018, or the Basic Education Enrollment Policy which institutionalized an efficient enrollment process in public and private schools and state/local universities and colleges (SUCs/LUCs), as well as provides the schedule of the conduct of early registration.
2. With the shift of the beginning of the school year (SY) from June to August in the previous years, the Department amends the schedule of the conduct of early registration in Paragraph V.A which shall read as follows:

**V. Enrollment Procedure**

**A. Early Registration**

**Early registration for the school year 2023–2024 of incoming Kindergarten, Grades 1, 7, and 11 learners in public schools shall be conducted from May 10 to June 9, 2023.**

3. Also, this reiterates the provision in DO 03, s. 2018, that all incoming learners enrolling in Kindergarten and Grades 1, 7, and 11 in all public elementary and secondary schools shall pre-register or participate in the early registration to allow DepEd to make the necessary preparations and adjustments of plans for the incoming SY 2023–2024. While incoming Grades 2–6, 8–10, and 12 learners from public schools are considered pre-registered, thus they do not need to participate in the early registration. However, private schools are encouraged to conduct their respective early registration activities in the same timeframe.
4. All public elementary and secondary schools shall update or encode daily in the Early Registration facility in the Learner Information System (LIS) using the school head or school administrator account. Public elementary and secondary schools shall use the print or electronic copies of the Basic Education Enrollment Form (Revised as of March 27, 2023) to ensure that necessary information in registering incoming Kindergarten, Grades 1, 7, and 11 learners, and other data, are properly captured.

5. Public elementary and secondary schools may also encode in the Early Registration facility, the prospective enrollees for other grade levels (e.g., Grades 2–6, 8–10, and 12) based on the previous school enrollment to get the overall picture of the expected enrollees for the next enrollment.
6. Preferably, the conduct of the early registration shall be done through face to face transactions with the schools. However, the schools may continue to implement other options or means of collecting early registration forms.
7. Authorities of public and private schools are instructed to strictly enforce and implement the kindergarten cut-off age as stipulated in DO 020, s. 2018 (Amendment to DepEd Order No. 47, s. 2016).
8. Schools division superintendents and school heads shall facilitate the conduct of advocacy campaigns within their respective jurisdictions to inform the general public and encourage Out of School Children (OSC) and parents/guardians of prospective learners to participate in the Early Registration for SY 2023–2024, by posting relevant materials in conspicuous places, and making announcements in local televisions and radio broadcasting stations.
9. All other provisions of DO 03, s. 2018, not otherwise affected or amended by this DepEd Order, shall remain valid and effective unless otherwise amended by other DepEd issuances.
10. This DepEd Order shall take effect immediately upon its approval, issuance, and publication on the DepEd website. Certified copies of this Order shall be registered with the Office of the National Administrative Register (ONAR) at the University of the Philippines Law Center (UP LC), UP Diliman, Quezon City.
