

- 1. Recognizing that education is a shared responsibility underpins RA 9155, which decentralized the system of school management. The Department issued DepEd Order No. 26, s. 2022, alternatively known as the Guidelines on the Establishment of School Governance Council (SGC), in accordance with the shared governance model. By involving schools and other community members as vital ground-level partners in the fulfillment of educational objectives, this approach aimed to maximize the joint efforts of all involved parties in the school environment.
- 2. To help schools and other supportive stakeholders better understand the roles of the SGC as a structure for shared governance and a feedback mechanism, BHROD-SED has released a series of infographics and other advocacy materials to support the SGC policy's implementation.
- 3. Through functional SGCs, stakeholders are given the opportunity to invite, involve, and influence the larger school community to actively participate in developing effective schools through decentralization.
