- 4. All applicants shall submit their application to the nearest Junior or Senior High School in their residence or school of their choice together with their letter of intent and pertinent documents as listed and placed in two (2) long folders with fastener.
 - a. Letter of Intent addressed to the Schools Division Superintendent. Attention: (School Head);
 - b. Duly accomplished CSC Form 212 (revised 2017) with Work Experience Sheet, if applicable;
 - c. Photocopy of valid and updated PRC License ID, if applicable;
 - d. Photocopy of Certificate of Eligibility/Rating, if applicable;
 - e. Photocopy of scholastic/academic record such as but not limited to Transcript of records (TOR) and Diploma, including completion of graduate and post graduate units/degree, if applicable;
 - f. Photocopy of Certificate/s of Training, if applicable;
 - g. Photocopy of Employment, Contract of service, or duly signed Service record, whichever is/are applicable;
 - h. NBI Clearance;
