# ADMINISTRATION OF THE NATIONAL LEARNING CAMP-ASSESSMENT (POST-TEST) FOR GRADE 8 AND GRADE 9 STUDENTS

1. In reference to the issuance of the Bureau of Education Assessment (BEA) DM-CT-2023-230 and Regional Memorandum No. 441 s. 2023, titled Administration of the National Learning Camp Assessment (Post-Test) for Incoming Grade 8 and Grade 9 Learners for School Year 2023 – 2024, schools of this division shall administer the Post-Test of the National Learning Camp for the incoming Grades 8 and Grade 9 on the following schedules:

- 2. The National Learning Camp Assessment (NLCA) Post-test will be administered to all Grades 8 and 9 learners for School Year 2023-2024 who took the PRETEST for NLCA last July 2023 in all public schools across country. The assessment tool intends to determine the effectiveness of the learning camp intervention on the learning proficiencies of participating learners before and after attending the said program.
- 3. The test shall cover learning areas in English, Science, and Mathematics, wherein test items measure varying levels of skills and competencies in a multiple-choice format using the English language.
- 4. All enrolled Grades 8 and 9 learners for SY 2023-2024 (who took the pretest) from all public schools should activate/access their DepEd LMS accounts using their official DepEd Microsoft accounts for the conduct of the NLC Assessment. School Testing and IT Coordinator should ensure that the learners have access to their DepEd Microsoft account and have accessed the DepEd LMS platform before the test administration.
