- The Adopt-a-School Program under the RA 8525 refers to the mechanism which allows private entities to assist public schools in particular aspect of educational program. Private individuals and partners including National Government Agencies, Local Government Units (LGUs), community, private individuals and civic societies and other stakeholders play an important role as they contribute and support to provide basic quality education. Recognizing their contribution to the Schools Division of Pampanga, the Social Mobilization and Networking Section under the School Governance and Operations Division will conduct the 2023 Education Stakeholders Summit on November 7 and 8, 2023, Otel Pampanga, Lazatin Boulevard, City of San Fernando, Pampanga.
- 2. The activity aims to:
  - o Give recognition to various education stakeholders on their support to the Matatag Basic Education agenda of the department;
  - To provide updates or accomplishment reports of the of DepEd SDO Pampanga; and
  - o To give information on the current resource gaps of schools and learners.

- The Public Schools District Supervisors (PSDSs) are requested to recommend four (4) Education Stakeholders per district and cluster to be recognized who have shown full support to our schools and learners. Kindly submit the names and details
