# 2023 DIVISION SEARCH FOR THE BEST ADVOCACY CAMPAIGN MATERIALS TO END VIOLENCE AGAINST WOMEN AND CHILDREN (VAWC)

- 1. In line with the 18-day Campaign to End Violence Against Women (VAW) which is observed annually from November 25-December 12, the Schools Division of Pampanga, through the School Governance and Operations Division-Human Resource Development Section (SGOD-HRDS) will conduct the Division Search for the Best Advocacy Campaign Materials to End Violence Against Women and Children (VAWC).
- 2. The activity aims to:
  - a. intensify the advocacy to end VAWC through the sharing of schools' best practices;
  - b. produce advocacy materials (print and visual ads) that will be used during the 18-day campaign;
  - c. promote public awareness in the SDO and schools on the observance of the 18-day campaign to end VAWC;
  - d. emphasize that VAWC is human rights violation; and
  - e. envision a world free from all forms of violence against women and children.
- 3. This year's Search shall focus on both print and visual ads as advocacy materials in the said Observance. See enclosed Guidelines on the Preparation of Advocacy Campaign Materials for information and guidance.
- 4. Public Schools District Supervisors and Education Program Supervisors (incharge of Clusters) through the District/Cluster GAD Focal Persons shall submit one (1) entry for print ads and one (1) entry for visual ads per district/cluster. All concerned are advised to strictly adhere with the specified timeline, thus, late entries will no longer be accepted. Accepted entries will be evaluated by the Division Evaluation Committee following the said guidelines enclosed to this Memorandum.



#### GUIDELINES ON THE PREPARATION OF ADVOCACY CAMPAIGN MATERIALS

1. The advocacy campaign material should be:

For Print Ads

7- -

 a three-fold flyer using A4 size bond paper. Use two or three different fonts to give the flyer design variety. The appropriate size of fonts used should be observed.

Submit ten (10) copies sealed in a short brown envelope, properly labeled.

For Visual Ads

- single poster type
  - Portrait orientation must have 720p x 1270p resolution
  - Landscape orientation must have 1270p x 720p resolution

Upload a copy of the material in a Google Drive to be shared at email add: <a href="mailto:kristinmarie.santos@deped.gov.ph">kristinmarie.santos@deped.gov.ph</a>, properly labeled.

- 2. Materials should be eye-catching enough to make people take interest in reading it. Colored entries are preferred but stick to colors that complement each other and work well.
- The advocacy materials should be informative; people should know at a quick glance what the materials is promoting, and all necessary points must be included.
- The materials must be quality assured for spelling, grammar, and content/information.
- 5. Original pictures/icons relevant to the campaign should be added to give aesthetic feature to the material.
- 6. The SDO shall disqualify the entries found to have been copied from existing materials used by the Philippine Commission for Women (PCW).
- 7. Criteria for Judging will be as follows:

a. Content 30%

b. Layout and illustration 25%c. Creativity 25%

d. Originality 20%
Total 100%
