In line with efforts to take good care of learners by promoting learner well-being, inclusive education, and a positive learning environment as one of the components under the MATATAG Agenda of the Department of Education, this Office hereby issues this memorandum to reiterate the various measures to be undertaken to ensure the safety and security of all learners in all public elementary and secondary schools in SDO Pampanga. This Office, through the School Governance & Operations Division (SGOD)-DRRM Unit reiterates the policies and guidelines to ensure the safety and well-being of learners on school premises.
- 2. Aside from the continuous implementation of programs, projects, and activities geared towards disaster preparedness and mitigation in schools, school heads and other personnel are reminded to ensure that school premises are void of hazardous objects, materials, chemicals, and other items that may pose danger to the learners.
- 3. Furthermore, school heads are requested to remind all concerned teaching personnel that school breaks such as recess and lunch periods must be teacher-guided.
- 4. Learners must be reminded not to loiter around the school premises and/or outside the school area to ensure their safety and security at all times.
