# DIVISION ORIENTATION ON THE CONDUCT OF THE PRESENTATION PORTFOLIO ASSESSMENT FOR ALTERNATIVE LEARNING SYSTEM ACCREDITATION AND EQUIVALENCY ELEMENTARY AND JUNIOR HIGH SCHOOL LEARNERS FOR SCHOOL YEAR 2023–2024

- 1. The Department of Education (DepEd), through the Curriculum and Teaching Strands and Bureau of Alternative Education (BAE), issued the Reiteration of DepEd Memorandum No. 22 s. 2023 as Basis on the Conduct of Presentation Portfolio Assessment (PPA) for Alternative Learning System (ALS) Accreditation and Equivalency (A&E) Elementary and Junior High School Learners for School Year (SY) 2023–2024.
- 2. In order to provide the appropriate program assessment for ALS A&E, the BAE decided to proceed with the conduct of PPA for the fifth year. As an alternative means of certification, the results of PPA Year 5 for ALS A&E Elementary Level (EL) and Junior High School Level (JHSL) Learners for SY 2023–2024 shall be used as bases for the issuance of the certificates.
- 3. In relation to this, a Division Orientation on the Conduct of Presentation Portfolio Assessment for Alternative Learning System Accreditation and Equivalency Elementary and Junior High School Learners for School Year 2023-2024 will take place on February 13, 2024 at San Matias ES Learning Center, Santo Tomas, Pampanga.
- 4. The participants of the said activity shall be the Education Program Supervisor (Division ALS Focal Person), Education Program Specialists for ALS, ALS Teachers, and ALS Facilitators. Travel expenses to be incurred in relation to the conduct of the activity shall be charged against local funds.
