6. All expenses incurred in the conduct of this Search by the participants and Search Committee shall be charged against local funds, subject to the usual accounting and auditing rules and guidelines.



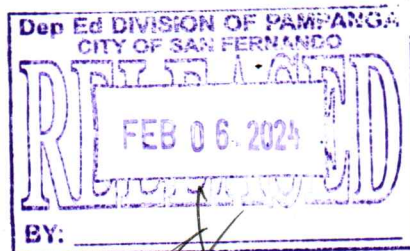

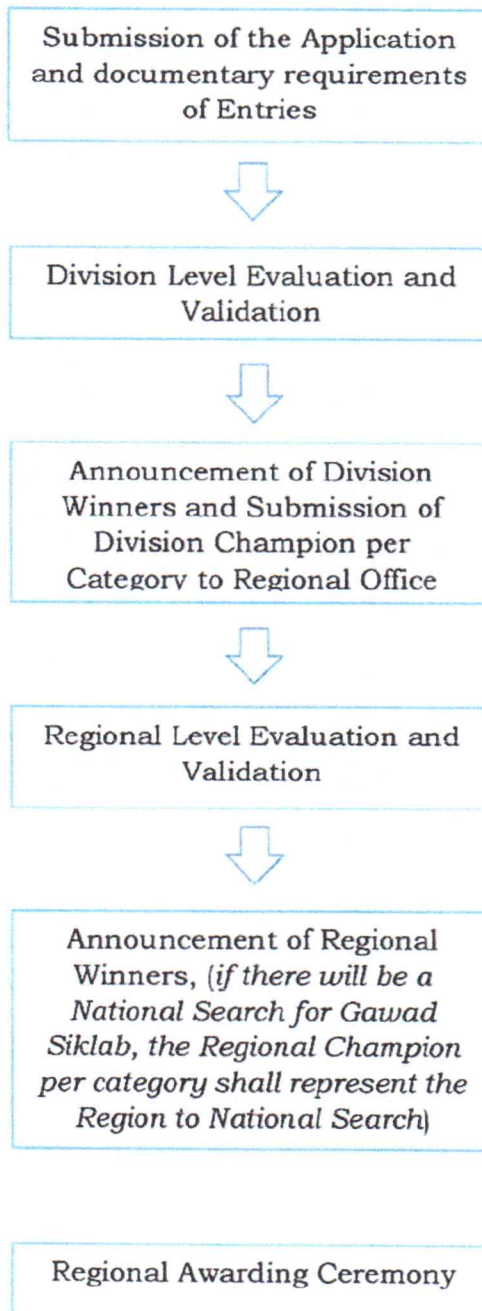

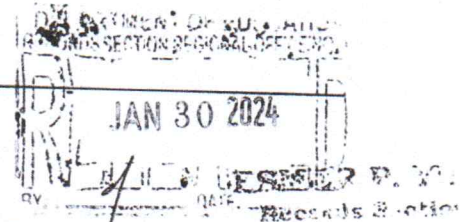

  - b. Encourage and motivate learner program implementers to plan and implement significant learner formation programs, project and activities responsive to address the pressing issues concerning today's learners and;
  - c. Sustain and promote high impact learner formation programs, projects and activities that lead leaners to become agents of change and responsible citizens.
4. The Learner Formation programs, projects and activities implemented/accomplished from August 2023 to April 2024 shall only be considered for the 2024 Gawad Pag-Gabay Search.


