# PREPARATION AND SUBMISSION OF FY 2025 BUDGET PROPOSALS

To : All Schools Division Superintendents

Regional Functional Division Chiefs Concerned

- 1. Relative to the preparation of the FY 2025 Budget Proposals called for under National Budget Memorandum No. 149 dated December 27, 2023, a shared responsibility to the preparation of a responsive budget shall be observed as follows:
  - a. The Personnel Services (PS) (BP Form 201-A) requirements shall be computed by the Regional Office (RO) Finance Division in coordination with the Personnel Unit and the Policy, Planning, and Research Division (PPRD);
  - b. The MOOE (BP Form 201-B) requirements shall be computed by the RO Finance Division in coordination with the PPRD using the formula to be provided by the Central Office;
  - c. The following division-consolidated proposals shall be provided by the Schools Division Offices (SDOs):
    - Requirements for the construction of classrooms, laboratory buildings, school furniture (student's table and chair sets and teacher's table and chair sets), new teacher positions, and textbooks and teacher's manual based on the eBEIS/LIS databases and using the PPRD – RO III templates (BP Form 201-D);
    - ii. Priority List of Classrooms/School Buildings Needing Repair;
    - Requirements for the Rehabilitation of Gabaldon School Buildings;
    - Requirements for the Electrification Project;
    - Replacement of School Furniture;
    - vi. Requirements for School Sites Surveying and Titling;
