1. Pursuant to DepEd Order No. 40 s. 2012 titled "DepEd Child Protection Policy" that aims to protect learners from abuse, violence, exploitation, bullying and all other forms of abuse.

2. Further, all public and private elementary and secondary schools shall establish a Child Protection Committee (CPC) which its compositions and

functions are stipulated in DepEd Order No. 40 s. 2012.

3. The Schools Division Offices through the Division Learner Rights and Protection Coordinator is mandated to assess the functionality of Child Protection Committee of schools.


