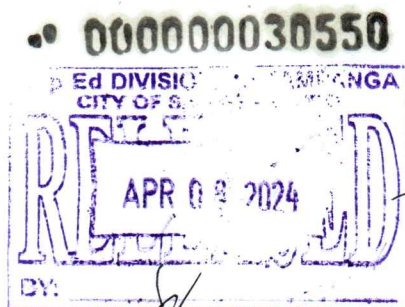
1. Aligned with DepEd's *Makakalikasan* core value and pursuant to DepEd Order No. 49, s. 2011 titled "*Mandated Programs, Projects, and Activities of the Supreme Student Government*," and DepEd Order No. 93, s. 2011 titled "*Mandated Programs, Projects and Activities, Various Forms, and Targets Pertinent to the Youth for Environment in Schools (YES) Program*," the SGOD – Learner Formation Unit is initiating the **Earth Day 2024 Tree Planting Activity** on **April 20, 2024 (Saturday)** in Nabuclod, Floridablanca, Pampanga.
2. This activity aims to:
 - a. encourage the youth to be involved in environmental initiatives and promote environmental stewardship in the community;
 - b. enhance the biodiversity and ecological resilience of the local area; and
 - c. encourage teamwork, leadership, and responsibility among participants.
3. The designated meeting point is the Nabuclod Barangay Hall. Assembly time is at 8:00 AM.
4. Participants are the identified SSLG and YES-O officers and teacher-advisers of Cluster 3. Each participant is kindly requested to bring one (1) variety of native, endemic, or indigenous tree sapling for planting during the activity.
5. Parental consents of the learner-participants are required to be sent to the Division Learner Formation Coordinator at rachelcamille.lacanlale@deped.gov.ph.
6. All teaching personnel are entitled to one (1) day of service credits as stipulated in DepEd Order No. 52, s. 2003. On the other hand, non-teaching personnel shall be provided with compensatory time-off per CSC and DBM Joint Circular No. 2, s. 2004.
7. AM snacks and lunch will be provided. Transportation and other incidental expenses incurred shall be charged to the school MOOE and other local funds subject to the usual accounting and auditing guidelines.
