- 1. The Department of Education (DepEd) Region III through the DepEd-National Employees Union Regional Chapter announces the conduct of the 2nd Director's Cup 2024 with the theme "Unionism in Sports".
- 2. The Director's Cup aims to strengthen the non-teaching personnel unity, camaraderie and friendly relationship through meaningful sports event and promotion of NEU values.
