2. They are expected to perform the following duties attached to their designation:
  - 2.1 serve as the district/cluster focal person and liaison officer for SELG/SSLG in addressing issues and concerns;
  - 2.2 take the lead in:
    - a. attending division meetings;
    - b. submitting reports on the implementation status of the Learner Government Program to the Division Learner Formation Coordinator;
    - c. coordinating all SELG/SSLG related activities;
    - d. initiating collaborative meetings with the schools in their respective district/cluster; and
    - e. conducting district/cluster SELG/SSLG PPAs;
  - 2.3 assist the DLFC in:
    - a. disseminating meeting minutes to all SELG/SSLG school leaders and teacher-advisers in their district/cluster;
    - b. consolidating and submitting reports to the DLFC; and
    - c. conducting LGP related PPAs in the Division; conducting
  - 2.4 act in accordance with the decisions and agreements made by the Division Federated SELG and SSLG; and
  - 2.5 perform any related tasks as assigned.
3. This designation entails no additional compensation/salary or claims for priority in promotion and may be revoked anytime by the School Governance and Operations Division Chief.
