- 1. Pursuant to Regional Memorandum No. 452, s.2024, titled "National Implementation of Learner Rights and Protection (LRP) On Wheels 2024," this Office, through the School Governance and Operations Division, hereby directs all Public Schools both elementary and secondary to implement the activity.



Pursuant to the DepEd Order No. 3 s. 2021, the Learner Rights and Protection Office (LRPO) serves as the lead office of the Department in formulating policies, planning, implementing, coordinating and monitoring projects, programs and activities concerning all matters pertaining to the rights of the learners in basic education.
- 2. Guided with the MATATAG framework, **Ta**ke good care of learners by promoting learner well-being, inclusive education, and a positive learning environment. 
