SDO PAMPANGA LEARNERS' WELFARE COUNCIL (LWC) DISTRIBUTION OF SOCIAL BEHAVORIAL CHANGE (SBC) POSTERS

- 1. Pursuant to Regional Memorandum No. 452, s. 2024 titled "National Implementation of Learner Rights and Protection (LRP) on Wheels 2024," this Office, through the School Governance and Operations Division (SGOD) Learner Formation Section, facilitates the conduct of the "SDO Pampanga Learners' Welfare Council (LWC) Distribution of Social Behavorial Change (SBC) Posters."
- 2. For the public schools, each district and cluster is allocated two (2) posters per category of SBC Posters. With eight (8) categories in total, a sum of sixteen (16) posters shall be received per district/cluster. These posters shall be posted on the conspicuous place within the school.
- 3. Meanwhile, for the private schools, each zone is allocated four (4) posters per category of SBC Posters. With eight (8) categories in total, a sum of thirty-two (32) posters shall be received per zone. These posters shall likewise be posted on the conspicuous place within the school.
- 4. Public School District Supervisors and Zonal Managers of Private Schools or any representative from each district/cluster/zone are advised to pick-up the SBC materials at the SGOD Office Learner Formation Section.
