- 1. Anchored on Regional Memorandum No. 661, s. 2023, titled Implementation Guidelines on the Adoption of the Ukit Marangal Framework in Support of the MATATAG Curriculum, and Regional Memorandum No. 86, s. 2024 titled Submission of Videos about Marangal na Mag-aaral, Marangal na Guro, Marangal na Empleyado, Marangal na Pinuno for Uploading in the Ukit Marangal Facebook this Office announces the Conduct of District/Cluster/School-Based Learning Action Cell Sessions (LACS) on Ukit Marangal and Implementation of Workplace Application Projects (WAPs) during the third and fourth quarters of 2024.
- 2. The objectives of the LACs are the following:
 - 2.1 provide technical assistance to teachers to improve their teaching competencies, and to integrate peace competencies, values and character development during instruction;
 - 2.2 integrate in school's SIP, AIP, and OPCRF the Ukit Marangal Framework in support of the MATATAG curriculum including activities that would strengthen the implementation of peace competencies;
 - 2.3 craft implementation plan relative to the Adoption of Ukit Marangal Framework in support of the MATATAG Curriculum; and
 - 2.4 search and award Marangal na Mag-aaral, Marangal na Guro, Marangal na Empleyado, Marangal na Pinuno at Marangal na Paaralan.
- 3. Public Schools District Supervisors (PSDSs)/Principals/School Heads are given the freedom to plan for the LACS based on their context and shall provide food and materials for teachers through their Maintenance and Other Operating Expenses (MOOE), canteen or local funds subject to the usual accounting and auditing rules.

Teachers are entitled of service credits as stipulated in the D.O. 53, s. 2003 titled Updated Guidelines on Grant of Vacation Service Credits to Teachers and Civil Service Commission, Department of Budget and Management Joint Circular No. 2, s. 2015 re: Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees respectively. It is recommended PSDSs/principals/school heads shall request for the vacation service credits of teachers supported with district/cluster/school memorandum, narrative report, pictures and Daily Time Record/s.
- 5. Implementation Plan of districts/clusters/schools should be submitted to the Schools Division Office- Curriculum Implementation Division following the attached template on Enclosure No. 1. on or before July 31, 2024.
