# GIRL SCOUTS OF THE PHILIPPINES (GSP)-PAMPANGA COUNCIL GUIDELINES ON THE VOLUNTARY SCHOOL CONTRIBUTIONS

- 1. As per DepEd Memorandum No. 041, s. 2024 titled "Reiteration of the No Collection Policy in Schools", paragraph number 2 states that collection of contributions is prohibited, *provided however* that this prohibition **shall not cover membership fees** of school children on the Red Cross, **the Girl Scouts of the Philippines** and the Boy Scouts of the Philippines.
- 2. Anent to this, the authorized voluntary contributions which includes the **GSP membership fees** for Girls and Adults can already be collected starting the second month of the School Year 2024-2025 (September), on a Voluntary Basis, authorized contributions as follows:
