Republic Act (RA) 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, mandated all government agencies to institutionalize policies, structures, coordination mechanisms and programs with continuing budget appropriation on disaster risk reduction and management (DRRM) from national to local levels. Moreover, RA 9155 or the Government of Basic Education Act of 2001 vested the Department of Education (DepEd) with authority, accountability and responsibility to ensure access to basic education which is often disrupted by emergencies and disasters.
