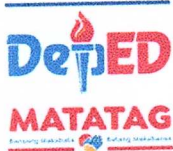

**2024 BOYSCOUTS OF THE PHILIPPINES (BSP)  
MEMBERSHIP CAMPAIGN**

To: Assistant Schools Division Superintendents  
Division Chiefs  
Public Schools District Supervisors  
Public and Private Elementary and Secondary School Heads  
All Others Concerned

1. The Department of Education issued DepEd Order No. 76, s. 2012 (Revitalizing Boyscouting in School Nationwide, recognizing the significant role of the Boy Scouts of the Philippines in aiding the school system to mold pupils and students into responsible and responsive citizens of the country and in contributing to efforts to achieve quality education. In support of the scouting movement, the Department encourages membership and participation in Boyscouting and its programs, projects and activities in schools.
2. The Department of Interior and Local Government (DILG) expressed its support for the BSP through DILG Memorandum Circular Number No. 2018-11 (Support to Boyscouts of the Philippines) enjoining all Provincial Governors, City Mayors, Municipal Mayors, Punong Barangays and other concerned officials to undertake activities such as sponsor and pay for the membership fees of public school children in their respective areas, or grant of financial assistance to their counterpart Council in furtherance of the scouting movement.
3. As school year 2024-2025 open the Department of Education reiterated that the membership for the Boyscouts of the Philippines are exempted from "No Collection Policy", through the issuance of DepEd Order No. 41, s.2024.
4. Membership Campaign may start on the second month after the opening of School Year as per DepEd Order No. 19, s.2008, titled: Implementation of No Collection Policy in All Public Elementary and Secondary Schools

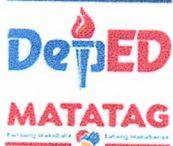
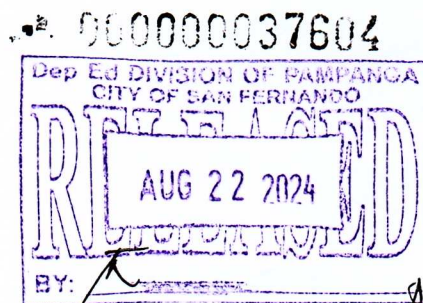

1. In reference with the [DepEd Order No. 49 s. 2007](#) entitled **REVITALIZING BOY SCOUTING IN SCHOOLS**, supported in [DepEd Order No. 76 s. 2012](#) entitled **GUIDELINES IN REVITALIZING BOY SCOUTING IN SCHOOLS NATIONWIDE**.
2. The **Boy Scouts of the Philippines (BSP) - Pampanga Council** encourages all schools in the DepEd Division of Pampanga, DepEd Division of City of San Fernando (P), and DepEd Division of Mabalacat City, both elementary and secondary, to promote the membership of their learners and teachers to the Boy Scouts of the Philippines for the **School Year 2024-2025**.
3. Scouting institutions may register their Scouts and Adult Leaders to the Boy Scouts of the Philippines through the Pampanga Council either to its office located at **Brgy. Poblacion, Sto. Tomas, Pampanga** or via any mobile registration nearby organized by District BSP Coordinators or any concerned Adult Leaders.
4. Each Scouting institutions are required to submit their list of Scouts to be registered using the following **BSP membership forms** accomplished in quadruplicate copy:

  - b. For additional Scout registration: [Application for Additional Scout Registration Form \(ASR\)](#)
  - c. For Adult registration: [Application for Adult Registration Form \(AAR\)](#)

BSP Membership is supported by the Department of Interior and Local Government through the [DILG Memorandum Circular No. 2018-11](#) with the subject **SUPPORT TO THE BOY SCOUTS OF THE PHILIPPINES**, in which local government units are enjoined to support the Boy Scouts of the Philippines through but not limited to membership sponsorship which may be chargeable against local funds subject to availability of funds.
  
7. Registered Scouts are entitled to the **BSP Financial Assistance Program** in case of any untoward incidents during Scouting activities, as detailed in [BSP National Office Memorandum No. 14 s. 2016](#), which includes the following (please refer to the memorandum for a more detailed scope of the BSP Financial Assistance Program):
  - a. Accidental Death **Php 20,000.00**
  - b. Hospitalization (In-patient) **Maximum of Php 15,000.00**
  - c. Hospitalization (Out-patient) **Maximum of Php 5,000.00**
  - d. Dismemberment **Maximum of Php 20,000.00** (%-based)

**Note that the BSP Financial Assistance Program only covers incidents during Scouting activities and events as defined in the memorandum.**
