ON-THE-SPOT POSTER MAKING CONTEST

Mechanics:

- 1. The contest is open to all public and private high school (Grade 7-12) students.
- Each contestant must bring with him a certification from the school principal that he is the official representative of his/her school for the said contest.
- 3. The contest proper will commence at 10:00 am and will end at 2:00 p.m. at the designated venue.
- 4. The theme of the contest will be derived from the Consumer Month Celebration 2018 theme: "Be Smart, Assert Your Consumer Rights".
- 5. The organizers will provide the materials for the said contest.
- 6. The materials which will be used are the following: (Note: Only the supplied materials shall be used)
 - · pencils, markers and erasers
 - illustration board
 - oil pastels
- 7. All artworks must be done only on the spot, and must be completed within the allotted time of four hours.
- 8. All entries will be pre-numbered. No signature, name, or other identifying mark should appear at either side of the material of the entry.
- 9. Criteria for judging shall be based from the following:

Relevance to the theme - 30%
Creativitv - 30%
Visual Impact - 30%

Adherence to the rules
 10% / TOTAL: 100%

- The entries shall be judged by a Panel of Judges consisting of competent artists and Consumer Welfare Officers.
- 11 The decision of the judges shall be final and irrevocable. Any administrative or technical problems that may arise during the contest shall be resolved by the organizers, whose decision, moreover, shall be final and irrevocable.
- 12. The 1st Place, 2rd Place and 3rd Place will be determined and declared as winners. They will receive certificates plus Php 3,000 worth of Gift Certificates, Php 2,000 worth of Gift Certificates and Php 1,000 worth of Gift Certificates respectively
