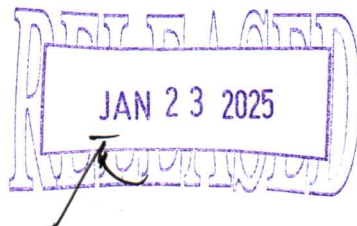
**HOLY CROSS COLLEGE PROGRAM OFFERINGS**
