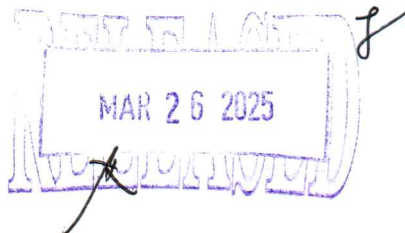
**APPROVAL OF CLRBI'S AUTHORITY TO UTILIZE THE AUTOMATIC PAYROLL

This refers to your request for CLRBI's authority to utilize the Automatic Payroll Deduction System (APDS) facility for its lending business to DepEd personnel under **APDS Code 1260** in the **Province of Pampanga, Region III**, in view of CLRBI's office, based on the following information:

Item 9.2 of the Terms and Conditions of the TCAA Accreditation (TCAA) for loans which you have entered on behalf of CLRBI states that ***"The Lender shall limit its operation to provinces/regions where it has offices and affiliate companies. The office shall employ a full-time manager or authorized personnel, and staff who shall maintain the complete records/loan documents, accept payments, issue SOA, OR, and CFPL, and attend to other loan transactions and any queries/complaints of DepEd personnel Annex 'G', which forms a compulsory part of this TCAA, contains the provinces/regions, including the names of its offices (main and branches) and affiliate companies, along, per province/region where the lender is authorized to operate."*** In addition, Item 10.1.7 of the TCAA requires that its offices per province listed in Annex G of the TCAA, along with the address, contact number, and the names of the managers and contact persons per office, be filed and updated by DepEd.

Considering that CLRBI has indicated its intention for the existence of an office in the Province of Pampanga, based on the information report submitted by the DepEd

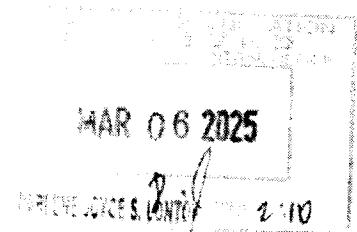
Region III AFDS Task Force, the request is hereby **approved**. It is understood that the said office shall also abide by all the provisions of the TCAA. This approval shall be an addendum to Annex C of CHED's TCAA.

In accordance with DepEd Order No. 20, s. 2021, the DepEd verifier should assess the amount of loans to be incorporated into the payroll prior to the approval of the accredited lender. In relation to this, the list of e-mail addresses of the corresponding DepEd verifiers in the Province of Pangasinana is herewith furnished for your reference. For implementing unit secondary schools within the said province, said units may only begin offering loans thereat upon the designation of DepEd verifiers and the creation of their corresponding e-mail addresses.
