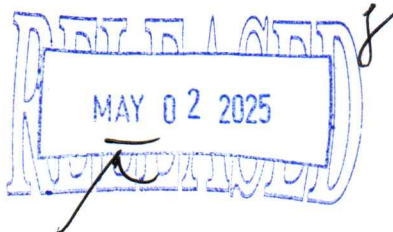
This initiative aims to support and protect our newly hired educators by providing them with free life insurance coverage for three (3) months amounting to ₱30,000, covering both natural and accidental death.
