## ATTENDANCE TO THE PRESENTATION OF HMO PROPOSALS IN PREPARATION FOR THE AGENCY PROCUREMENT OF HMO SERVICES

Pursuant to DepEd Order No. 16, s. 2025, entitled "Guidelines on the Grant of Medical Allowance through Agency Procurement of HMO Services," and in accordance with Republic Act No. 9184, otherwise known as the Philippine Government Procurement Reform Act, and its 2016 Revised Implementing Rules and Regulations (IRR), the Schools Division of Pampanga shall conduct a Presentation of HMO Proposals on July 22, 2025 at the Teachers' Training Center (TTC), DepEd SDO Pampanga.

As part of procurement planning and market study requirements under RA 9184 and its IRR, this activity supports the development of project specifications and the formulation of the Approved Budget for the Contract (ABC). It upholds the principles of transparency, competitiveness, efficiency, accountability, and equity in the procurement process.

A well-documented market survey—such as this activity—ensures transparency and economy in procurement by:

Comparing alternatives based on:

- Value for money
- · Risk management
- Government policy alignment
- Other relevant technical or performance criteria

Based on the results of the recently conducted HMO Provider Survey by the Division Office, the Top Five (5) most preferred HMO providers have been identified and invited to present their HMO packages and service offerings. The presentation will serve as a venue to clarify options, gather feedback, and support informed procurement decisions.
