Your voluntary financial assistance will be of great help in alleviating her financial burden. Donations may be sent through the following account:

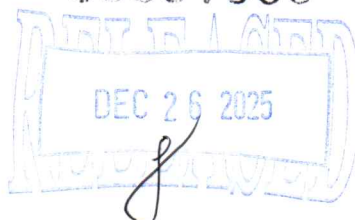
