- 1. In accordance with Section 5 (b) of Republic Act No. 6713 otherwise known as An Act Establishing a Code of Conduct and Ethical Standards for Public Officials and Employees, to Uphold the Time-honored Principle of Public Office Being a Public Trust, Granting Incentives and Rewards for Exemplary Service, Enumerating Prohibited Acts and Transactions and Providing Penalties for Violations Thereof and for Other Purposes, all heads or other responsible officers of offices and agencies of the government and of government-owned or controlled corporations shall within 45 working days from the end of the year, render a performance report of the agency or office or corporation concerned.
- 2. Anent to the foregoing, this Office announces the writeshop and preparation of the Schools Division of Pampanga's Accomplishment/ Annual Report and Evaluation of Organizational Performance for 2024 on January 8-10, 2025 at a venue to be announced.
- 3. This FY 2024 consolidated report shall summarize the overall performance of SDO Pampanga, encapsulating the key achievements across pillars.
- 4. The objectives of the activity are as follows:
 - a. Gather accurate and relevant data from various sources within the SDO:
 - b. Document all significant achievements, programs, and initiatives undertaken by SDO Pampanga in 2024;
 - c. Write clear, concise, and engaging content for the report; and
 - d. Communicate the 2024 accomplishments and progress of SDO Pampanga to stakeholders.
