- The field is hereby informed that the official mobile application (GSIS Touch) of the Government Service Insurance System will soon serve as the central hub for accessing its services. Therefore, enrolling in this application is essential for facilitating transactions with the agency.
- With this, all employees in this Division who haven't yet downloaded and 2. enrolled in the GSIS Touch/GTOUCH are mandated to download and enroll in the said mobile application immediately per Memorandum No. 024, s. 2025 from the DepEd Region III Office to avoid the possible incurrence of problems in processing members' benefits and other transactions once the operation of kiosks is totally stopped.
- Please update your mobile phone number with the Division's Agency 3. Authorized Officer (AAO) at the Personnel Section before registering with GTOUCH, as the One-Time PIN (OTP) will be sent to your registered contact number for authentication.

- 1. The Government Service Insurance System (GSIS) Pampanga Office reported that there are still employees in your respective Divisions who are not yet enrolled with the GSIS Touch, a mobile application provided by the GSIS in lieu of the kiosks and over- the-counter transactions with the System.
- 2. Please be advised that the GSIS Pampanga Office have started gradually pulling-out the operations of the kiosks and over-the-counter transactions, which are being replaced by the implementation of the GSIS Touch application.
- 3. Accordingly, please advise concerned employees to immediately enroll with the GSIS Touch App to avoid the possible incurrence of problems in the processing of members' benefits and other transactions once the operation of the kiosks will be totally stopped.
- 4. A copy of a Powerpoint presentation on the process of the enrollment was provided by the GSIS Office to assist members. It also includes the discussion of the benefits and other salient features of the application.
