REORIENTATION-MEETING FOR PRIVATE SENIOR HIGH SCHOOL (SHS) FOCAL PERSONS RE: APPLICATION FOR THE ISSUANCE OF SPECIAL ORDERS OF QUALIFIED GRADE 12 LEARNERS, SY 2024-2025

- Pursuant to DepEd Order No. 10, s. 2018, otherwise known as "Guidelines on the Issuance of Special Orders for the Approval of the Eligibility for Graduation from Senior High School of Grade 12 Learners Enrolled in Private Schools / Colleges and Technical-Vocational Institutions," the Regional Office is authorized to issue Special Orders to schools that were issued provisional permits to operate for the graduation of qualified Grade 12 learners.
- 2. The issuance of special orders, in accordance with the guidelines stipulated in DepEd Order No. 88, s. 2010 or the Revised Manual of Regulations for Private Schools in Basic Education shall be filed by the school through the Schools Division Office (SDO) at least 15 calendar days before the end of the current academic year.
- 3. In reference to the foregoing, this Office announces a reorientation meeting for Senior High School (SHS) focal persons of private and technical/vocational schools on **March 5, 2025** at 8:00 a.m. The meeting will be held at the Teacher Training Center (TTC), SDO Pampanga, High School Blvd., Brgy. Lourdes, CSF(P).
- 2. The following topics shall be discussed during the meeting:
 - a. Overview of the Special Order application process
 - b. Requirements for graduation eligibility


