DIVISION MEMORANDUM NO. 157, s. 2025

February 24, 2025

REITERATING THE DEPED POLICY ON THE END OF SCHOOL YEAR RITES

- The Department of Education issued to the field the Deped Order No. 09 s. 2023 or the "An Order Updating the Multi-Year Implementing Guidelines on the Conduct of the K to 12 Basic Education Program End of School Year Rites"
- 2. Deped reiterates the following policies:
 - a. Graduation and Moving Up Ceremonies should be simple yet meaningful. While these rites mark a milestone in the life of the learners, these should be conducted without excessive spending, extravagant attire or extraordinary avenue.
 - b. Non-academic projects articulated in DO No. 66 s. 2017, entitled "Implementing Guidelines on the Conduct of Off-Campus Activities such as attendance to field trips, film showing, JS Promenade and other school events should not impose as requirements for graduation or completion.
 - c. The formats of the certificate of completion and diploma must be in accordance with enclosure 1 pages 44 to 46 of DO No. 31 s. 2019 entitled "The Department of Education Service Marks and Visual Identity Manual"
 - d. Guidelines in the awarding of honors to learners from Grade 1 to 12 as stipulated in DO No. 36 s. 2016 entitled "Policy Guidelines on Awards and Recognition for K to 12 Basic Education Program" shall be followed.
 - e. Moving up or graduating rites shall be conducted in an appropriate solemn ceremony befitting the graduating students and their family and shall not be used as a political forum, in strict compliance with Do No. 48 s. 2018 entitled "Prohibition of Electioneering and Partisan Political Activity".
 - f. No Deped Personnel shall be allowed to collect any kind of graduation/ moving up fee.
 - g. Casual or formal wear, or school uniform, shall remain as the recommended moving up/ graduation attire. Toga or Sablay is allowed to be worn as an additional garb.
- 3. Expenses relative to the Graduation and Moving Up Ceremony shall be charged against the School's Maintenance and Other Operating Expenses (MOOE) such as:



- a. Medals with Deped Seal (consistent with the guidelines per Deped Order No. 31 s. 2019 and Deped Order No. 21 s. 2022)
- b. Rental of Sound System
- c. Diploma and Certificates consistent Deped Order No. 31 s. 2019 (no separate cost for lettering of names and shall be given to recipients inside a Brown Envelope only)
- d. Rental of Chairs
- e. Documentary Stamp Tax (for SHS Graduates only)
- f. Stage Decoration (eg. flowers and other supplies)
- g. Tarpaulin Printing
- h. Office supplies for printing of simple programs and invitations
- i. Sablay or rental of Toga
- 4. Procurement of the above shall be in accordance with RA 9184 and payment shall be through issuance of check.
- 5. Wide dissemination of and strict compliance with this Memorandum is directed.
