- Considering the crucial updates and announcements concerning private schools, the Schools Division Office (SDO) of Pampanga, through the School Management Monitoring & Evaluation (SMM&E) Section, is set to facilitate the SY 2024-2025 Private Schools' Quarter 4 Coordination Meeting, scheduled on March 21, 2025, 8:00 a.m., at Otel Pampanga, Lazatin Blvd., Sky Plaza Building, City of San Fernando, Pampanga.
- 2. This concerted effort, as a crucial component of Project SAUPP: Strengthened Assistance through Unified Programs and Projects, aims to unite the heads of private schools and private technical-vocational institutions in a platform for dialogue and collaboration, helping to keep private school leaders informed and aligned with the most recent developments and priorities, and to tackle significant matters geared towards the continuous improvement of private education in the schools division.
- 3. The registration fee of ₱1,500 per person is compulsory for all school heads, to be collected and managed centrally by the Zone Managers to ensure coverage of the meeting's operational costs.
- 4. As a reiteration, participants in the activity are, strictly, PriSAP members only, as their presence is crucial for the election of officers. This policy is enforced to ensure that discussions and decisions are made by those actively engaged in the association, thereby upholding the integrity and relevance of the electoral process.
- 5. Furthermore, Sectorial Managers, who shall represent the Public Schools District Supervisors, are also encouraged to join the coordination meeting.


