# REVALIDATION OF THE EXISTING SPECIAL CURRICULAR PROGRAM (SCP) IN SCIENCE IMPLEMENTING SCHOOLS

- 1. With reference to the guidelines on the implementation of the Special Curricular Program (SCP) in Science by the Central Office, in line with the Regional Memorandum No. 135, s. 2025, titled Lifting of the Moratorium on the Submission, Processing, and Evaluation of Applications for the Special Curricular Program in Science, this Office, through the Curriculum Implementation Division (CID), encourages the twenty-six (26) schools to continue undergoing school-based assessment to identify areas for improvement and prepare for the conduct of revalidation of the program.
- 2. During the revalidation process, the EPS-in-charge of Science shall monitor the following:
  - a. Professional Development of teachers handling special science classes including attendance to relevant training or seminars and graduate studies;
  - b. Physical Facilities (Science laboratories, Math laboratory, ICT/Robotics Laboratory, Library);
  - c. Class Program;
  - d. Curriculum Implementation;
  - e. Instructional Delivery Approaches/Strategies;
  - f. Assessment of Learning Outcomes and Grading; and
  - g. Program Implementation Performance Indicators which include the achievement rate of learners, completion rate, survival rate, and tracking of learners (Number of SSES graduates enrolled in the Grade 7 STE Program, Number of Grade 10 STE completers enrolled in STEM).
- 3. All existing SCP implementing schools must present and submit their Beginning of School Year (BOSY) Report (refer to Enclosure 1 of Regional Memorandum No. 135 s.2025) and the End of School Year (EOSY) Report (refer to Enclosure 2 of Regional Memorandum No. 135 s.2025) to the Schools Division Office by regular compliance protocols. These reports are essential in assessing the fidelity of SCP
