**2025 SEMINAR-WORKSHOP ON THE STRENGTHENING OF CHILD PROTECTION
COMMITTEE AND LEARNER RIGHTS PROTECTION IN SCHOOL FOR PUBLIC
ELEMENTARY SCHOOL HEADS**

1. Pursuant to the 1987 Constitution, the State shall protect and promote the right of all children to accessible and quality basic education. Alongside this right is the constitutional policy that the State shall promote and protect their holistic development through the promotion of their physical, moral, spiritual, intellectual, and social well-being.
2. To further strengthen the implementation of DepEd Order No. 40, s. 2012 or the DepEd Child Protection Policy, this Office, through the School Governance and Operations Division (SGOD) Learner Formation Unit, conducts the second leg of **"Seminar-Workshop on the Strengthening of Child Protection Committee and Learner Protection in School"** on **May 14 to 16, 2025** at Otel Pampanga, City of San Fernando, Pampanga.
3. Participants of the said activity shall be selected School Heads from public elementary schools, preferably those who have not yet undergone any training related to Child Protection. The Public Schools District Supervisors (PSDSs) shall take the lead in identifying and selecting four (4) school head participants per district.
4. All selected participants are required to pre-register through the following link on or before May 6, 2025:

Selected school heads per district are encouraged to extend support to their fellow school heads who were unable to attend the training by providing technical assistance on matters related to Child Protection that were discussed during the seminar-workshop. This initiative aims to foster a wider understanding and implementation of Child Protection Policy across schools.



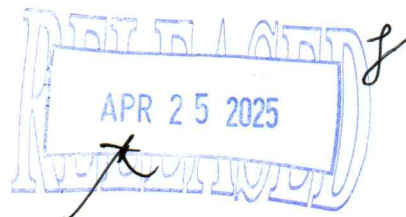
