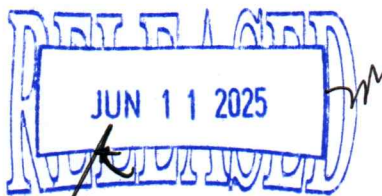

1. In accordance with DepEd Order No. 16, s. 2023, titled 'Revised Guidelines on the Implementation of the DepEd Computerization Program (DCP),' the program seeks to equip public schools with relevant, high-quality, and equitable technologies to strengthen teaching, learning, governance, and operational functions, as well as related programs and policies, in response to the demands of the modern era.
2. Anent to this, the Schools Division of Pampanga, through the Information and Communications Technology (ICT) Unit and the Property and Supply Unit, announces the distribution of laptops under the DCP FY 2025 Laptops for Non-Teaching (L4NT) Packages to selected Administrative Officers on **June 17-19, 2025**, from 9:00AM to 3:00PM at the Property and Supply Office.
3. The Office of the Administrative Officer V has provided a list of qualified recipients in accordance with the guidelines set by the ICTS. The list of recipients is attached as Enclosure 1.
4. Recipients are instructed to return any previously issued laptops or desktop computers to their respective schools or stations prior to receiving the DCP packages. They are also required to present a certification from the school head or head of office confirming that they have not been issued any laptops or desktop computers.
