**REITERATION OF COMPLIANCE ON THE CREATION AND  
SUBMISSION OF THE SCHOOL COMMITTEE ON ANTI-RED TAPE (SCART)  
FOR CY 2025**

To: Public Elementary and Secondary School Heads  
Teaching and Non-Teaching Personnel  
All Others Concerned

1. Pursuant to **DepEd Memorandum (DM) No. 040, s. 2025** titled "*Updated Composition of the Department of Education Committee on Anti-Red Tape in the Central Office and Sub-CART in Field Offices and Schools*" dated April 28, 2025 and **Memorandum DM-OUHROD-2025-1479** titled "*Submission of the List of DepEd Committee on Anti-Red Tape (CART) and Sub-CART Members for FY 2025*," all schools are reminded to strictly comply with the provisions of the said memoranda by creating their respective School Committees on Anti-Red Tape (SCART).
2. In line with the above directives, all schools within the Division of Pampanga are hereby requested to revisit and strictly adhere to previously issued Division memoranda pertinent to Anti-Red Tape initiatives and ensure that their respective SCART committees are properly organized, functional, and actively engaging in streamlining processes, reducing bureaucratic red tape, and enhancing service delivery.
3. The composition of the Division Committee on Anti-Red Tape (DCART) is reiterated as stated in **Division Memorandum No. 195, s. 2025**. School heads are enjoined to ensure their alignment with this composition in their school-level committees.
4. All School Heads are directed to submit the complete and updated list of their respective SCART to the Division Office through the Office of the Administrative Officer V, **on or before June 27, 2025. Only schools that have not yet complied shall encode their SCART through the provided link: <https://forms.office.com/r/TVc0Z1CfcX>**, as specified in Division Memorandum No. 181, s. 2025. **Schools that have previously submitted via this link do not need to resubmit.**

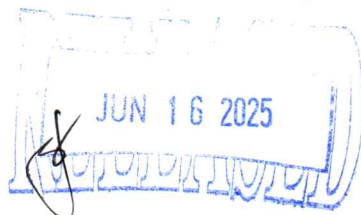
