PARTICIPATION OF SCHOOLS IN THE 2025 REGIONAL MOBILE SCIENCE CENTRUM (RMSC)

- 1. The Department of Science and Technology (DOST) in partnership with the Provincial Government of Pampanga and Vista Mall Pampanga will conduct the Second Year of the Regional Mobile Science Centrum (RMSC) from August 5 to August 15, 2025, at Vista Mall, San Fernando Pampanga.
- 2. The mobile science centrum aims to promote science literacy and innovation among learners through interactive exhibits, hands on experiments, and demonstrations aligned with the Revised K to 12 Curriculum.
- In view of this, all public elementary and secondary schools in the Schools Division
 Office of Pampanga are encouraged to participate in scheduled visits to the
 Centrum.
- 4. Participation in the activity shall be **strictly voluntary** and shall not disrupt the regular conduct of classes. Schools are advised to ensure compliance with safety, supervision, and transportation protocols.
- 5. School heads of the participants are advised to assign relieving teachers to maximize time-on-task stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith.*
- 6. The venue will be charged to the DOST Funds while the snacks, travel and other incidental expenses of the participants shall be charged to the School Local Funds subject to the usual accounting and auditing rules and regulations.
- 7. All school heads are enjoined to provide the necessary support for the success of this program and ensure proper documentation of participation.
- 8. This division memorandum shall serve as the travel authority of all concerned.
