
SUBMISSION OF CANTEEN FINANCIAL PLAN FOR SCHOOL YEAR 2025-2026

- 1. In accordance with DepEd Order No. 8, s. 2007, titled "Revised Implementing Guidelines on the Operation and Management of School Canteens in Public Elementary and Secondary Schools," this Office reiterates the responsibility of all public schools to maintain transparency, accountability, and proper documentation in the management and operation of their school canteens. More so, as stipulated in the General Guidelines for School-Managed Canteen, section 6.7 states that the expected income of the school canteen, the school head/principal shall prepare an Annual Budget to be submitted to and approved by the Schools Division Superintendent or his/her representative at the start of every school year.
- 2. In line with this, all schools are requested to submit their Canteen Financial Plan for the S.Y. 2025-2026 through the Division Coordinator in EPP/TLE/TVL, Garry I. Dela Cruz, PhD. Moreover, Canteen Financial Report for S.Y. 2024-2025 must be prepared and submitted as reference.
- 3. Deadline of submission is on or before August 30, 2025, following the attached templates.
- 4. School Heads shall ensure the accuracy, completeness, and timely submission of these reports. Non-compliance may affect the school's accreditation in canteen operations and its eligibility for future canteen-related support or initiatives.
