- 1. Section 16 of the RA 7160 (Local Government Code of 1991) states that Local Government Units are considered major partners in basic education because of its access and legal basis to provide supplementary funding support that is sustainable and earmarked for basic education- the Special Education Fund (SEF). The former Sec. Leonor Magtolis emphasized that "education is a shared responsibility" which requires commitment and collaboration from all agencies, local government units and other organizations who have interest in education. Engagement of stakeholders for support and collaboration is one of the pillars of aggressive reforms for quality education.
- 2. In line with this, the Schools Division Office of Pampanga through the Social Mobilization and Networking Section under the School Governance and Operations Division (SGOD) shall conduct the "2025 Local Government Unit (LGU) Forum" on August 20, 2025 8:30AM-2:30PM at the Teachers Training Center, SDO Pampanga, High School Boulevard, Brgy. Lourdes, City of San Fernando, Pampanga to address education related challenges especially on literacy and numeracy. The main purpose is to have a unified effort in delivering quality education through partnership.
 - 3. The activity aims:
 - To synergize efforts and resources to address education related challenges in the division;
 - b. To orient stakeholders on the assistance needed by the department to attain the Five Point Reform Agenda of the President;
 - b) To share the best practices of the barangays on their support to their schools;
 - c) To present the current status, challenges of the division and menu of investment to our LGU partners; and
 - d) Formulate plan of action to address gaps of current education status.
