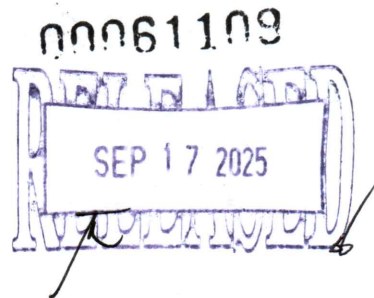

GSP CANCELLATION OF THE COUNCIL FUND DRIVE

1. In compliance with the DepEd Memorandum No. 041, s. 2024 and Division Memorandum No. 545, s. 2025, "Reiteration of the Strict Compliance of the "NO COLLECTION POLICY" in Schools, prohibiting the collection of fees from learners during the enrollment period and at any time during the school year including the sale of tickets and/or the collection of contributions in any form whatsoever, by any person from any project or purpose, whether voluntary or otherwise, from school children, students and teachers of public and private schools, colleges and universities, provided, however that this prohibition shall not cover membership fee of school children and students to the Girl Scouts of the Philippines.

2. In line with this, the **Girl Scouts of the Philippines (GSP) Pampanga Council** announced the **CANCELLATION OF THE COUNCIL FUND DRIVE** launched last September 03, 2025, and the GSP Office will be collecting all the tickets distributed to all districts and schools and requires the return of the proceeds or any amount collected from the sponsors. Further, in any case that these tickets will be used for any form of fund raising, kindly take notice of the said cancellation and is already considered invalid.

3. The GSP will continue to comply with the rules, regulations and standard of the Department of Education, considering each other as partners in the SERVICE FOR THE GIRLS!
