- In partnership with the Department of Trade and Industry (DTI), the Schools
  Division of Pampanga announces the conduct of the Division DTI On-theSpot Poster Making Contest, in celebration of Consumer Welfare
  Month this October. The activity will be held on October 27, 2025, 9:30 AM
  to 3:00 PM at the Walter Mart Activity Area, City of San Fernando,
  Pampanga.
- 2. The theme for this year's contest is derived from the Consumer Month Celebration 2025 theme: "Bida ang Konsyumer sa Bagong Pilipinas."
- 3. The participants will come from the twenty-five (25) identified public secondary schools. Each school shall send one (1) representative, either from Junior or Senior High School. A certification from the school head confirming the participant as the school's official representative is required.
- 4. The Department of Trade and Industry will provide all the materials to be used during the contest. Only these materials shall be utilized by the participants.
- 5. Enclosed are the Mechanics and Criteria for Judging, as well as the list of participating schools.
- 6. This Memorandum shall serve as the Travel Authority for the teacher coaches. Transportation allowance for both participants and coaches may be charged against the school's MOOE or any available local funds, subject to the existing accounting and auditing rules and regulations.

## ON-THE-SPOT POSTER MAKING CONTEST

Mechanics:

- 1. The contest is open to all public and private high school (Grade 7-12) students.
- 2. Each contestant must bring with him a certification from the school principal that he is the official representative of his/her school for the said contest.
- 3. The contest proper will commence at 10:00 am and will end at 2:00 p.m. at the designated venue.
- 4. The theme of the contest will be derived from the Consumer Month Celebration 2025 theme: "Bida ang Konsyumer sa Bagong Pilipinas".
- 5. The organizers will provide the materials for the said contest.
- 6. The materials which will be used are the following: (Note: Only the supplied materials shall be used)
  - · pencils, markers and erasers
  - illustration board
  - oil pastels
- 7. All artworks must be done only on the spot, and must be completed within the allotted time of four hours.
- 8. All entries will be pre-numbered. No signature, name, or other identifying mark should appear at either side of the material of the entry.
- Criteria for judging shall be based from the following:
  - Relevance to the theme
    Creativity
    Visual Impact
    30%
    30%
    30%
  - Adherence to the rules
     10% / TOTAL: 100%
- 10. The entries shall be judged by a Panel of Judges consisting of competent artists and Consumer Welfare Officers.
- 11. The decision of the judges shall be final and irrevocable. Any administrative or technical problems that may arise during the contest shall be resolved by the organizers, whose decision, moreover, shall be final and irrevocable.
- 12. The 1<sup>st</sup> Place, 2<sup>nd</sup> Place and 3<sup>rd</sup> Place will be determined and declared as winners. They will receive certificates plus Php 5,000 worth of Gift Certificates, Php 3,500 worth of Gift Certificates and Php 2,500 worth of Gift Certificates respectively.
