**DIVISION-WIDE SURVEY ON THE FORMULATION OF THE SDO PAMPANGA  
DRRM-LEARNERS' WELFARE COUNCIL (LWC) RECOMMENDED  
LOCALIZED SCHOOL-BASED CHILD PROTECTION POLICY**

1. Pursuant to the provisions of DepEd Order No. 40, s. 2012 (DepEd Child Protection Policy) and in consonance with relevant laws and issuances such as Republic Act Nos. 7610, 9775, 10627, 11596, and 11930, the Schools Division Office of Pampanga, through the SGOD- Planning and Research Unit and the Division Child Protection Committee (DCPC), shall undertake a **Division-Wide Survey on the Formulation of the SDO Pampanga DRRM-Learners' Welfare Council (LWC) Recommended Localized School-Based Child Protection Policy**.
2. The objective of this initiative is to collect relevant data, insights, and contextual information that will serve as the basis for the formulation of the SDO Pampanga Localized School-Based Child Protection Policy. This policy aims to ensure that every school within the Division adopts a context-responsive and inclusive framework that upholds the rights and welfare of learners while reinforcing mechanisms for protection, reporting, intervention, and accountability.
3. The results of the survey will be consolidated and analyzed to guide the development of the recommended localized policy, which will serve as an operational reference for schools in promoting safe, supportive, and child-friendly learning environments.
4. All information gathered through this instrument shall be treated with strict confidentiality and shall be used solely for research and policy

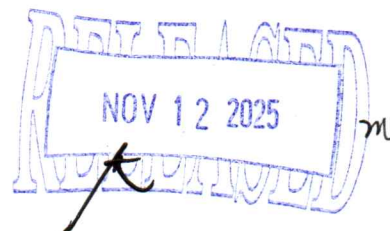
development purposes. No personal identifiers will be disclosed in any report, analysis, or publication resulting from the survey.
