- 1. In view of the implementation of the Fiscal Year 2025 National Assessment for School Heads (NASH) Batch 2, this Office, through the Human Resource Management Office (Personnel Unit), with the assistance of School Governance and Operations Division-Human Resource Development Section (SGOD-HRDS) shall conduct the profiling of prospective takers in accordance with the Evaluation and Validation Process of FY 2025 NASH Application and based on the established parameters and qualification standards stipulated in the DepEd Memorandum No. 69, s. 2025 titled "Administration of the National Assessment for School Heads (NASH) for Fiscal Year 2025" and DepEd Memorandum DM-OUHROD-2025-2392 titled "Supplemental Guidelines on the Validation and Final Submission of Takers of FY 2025 National Assessment for School Heads (NASH) Batch 1."
- 2. In accordance with the provisions of DepEd Memorandum No. 69, s. 2025, the list of Prospective Takers for the FY 2025 Batch 2 is as follows:
  - a. Head Teachers and Assistant School Principals (whether or not they meet the QS for School Principal I)
  - b. FY 2021 NQESH Category C takers
  - c. FY 2023 NQESH Category B and C takers
  - d. Other personnel who are qualified based on the new CSC-Approved QS
- 3. Likewise, as stated in DepEd Order No. 97, s. 2025, titled "Results of the National Assessment for School Heads for Fiscal Year 2025 Batch 1," Head Teachers (HTs) and Assistant School Principals (ASPs) whose competency level is classified as With Development Areas may opt to take the FY 2025 NASH Batch 2.
