 - Develop a standardized framework for BKD seminar projects across all clusters;



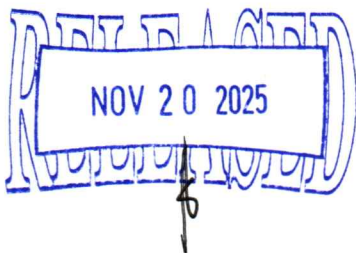
