



1. Pursuant to DepEd Order No. 40, s. 2012, or the *Child Protection Policy*, all schools shall formulate and adopt a localized Child Protection Policy (CPP). This requirement is also part of the Child Protection Committee (CPC) Functionality Assessment Tool, which evaluates schools on their development and implementation of a localized CPP.
2. To strengthen child protection mechanisms and provide assistance to schools under this Division, this Office, through the **SGOD – Learner Formation and DRRM Unit**, will conduct the **Writeshop on the SDO Pampanga DRRM- Learner's Welfare Council (LWC) Recommended School-Based Child Protection Policy with Standard Operating Protocols (SOPs)**.
3. This activity aims to develop a recommended School-Based Child Protection Policy with Standard Operating Protocols (SOPs) for SDO Pampanga Schools, through the active involvement of selected school heads, guidance counselors and designates, and other key stakeholders.
