**25th PROVINCIAL SCOUT JAMBOREE**

1. This Memorandum is issued to inform and enjoin participation in the 25th Provincial Scout Jamboree to be held on **February 15-21, 2026 at Floridablanca National Agricultural School – Main Campus, Floridablanca, Pampanga** with a **theme: “Be Prepared: Scouts for Peace and Sustainable Development”**

The activity aims to bring together Scouts from various units and districts in a spirit of unity, friendship, and shared commitment to the ideals of Scouting, aligned with the Department of Education’s thrust on youth development, leadership formation, and values education.

2. Participants shall be the registered Scouts and Scouters of the Schools Division Office of Pampanga who are physically able to participate in the different activities and who have duly signed parental consent and medical certificate. All participants must wear the prescribed Type A or Type B Scout Uniform.

3. As approved during the Local Council Executive Board (LCEB) Meeting, the number of participants shall be as follows, at least:

One hundred (100) participants per district

Secondary Schools: Seventy-two (72) for Fiscal Autonomous

Thirty-six (36) for Non-Fiscal Autonomous

4. A registration fee of Five Hundred Pesos (PhP 500.00) shall be charged to Scouts and Scouters to defray administrative expenses including, but not limited to, program materials, Jamboree kits and souvenirs, and venue rental and utility fees. The registration fee may be charged against the school MOOE/ Local funds/LGUs/School Canteen/PTA fund and other

donations, subject to existing accounting and auditing rules and regulations.

5. Food and other incidental expenses incurred by the participants shall be charged against local funds, LGUs, School Canteen, PTA funds, and other donations, subject to availability and the usual accounting and auditing procedures.

6. Payment of the registration fee may be made through the **BSP Pampanga Council Office located at Sto. Tomas, Poblacion Market**, or through bank deposit with the following details:

7. The deadline for submission of registration and payment is February 2, 2026. **ON-SITE REGISTRATION SHALL NOT BE ACCEPTED.**

8. The District Commissioner shall facilitate coordination with the Local Government Unit (LGU) for the provision of additional supplemental water supply, including the deployment of a fire truck, for the duration of the activity.

9. In line with safety requirements, the BSP Pampanga Council and DepEd Pampanga shall conduct necessary inspections and provide appropriate measures to ensure the safety and protection of all participants.

10. Teacher participants may join the activity subject to the non-disruption of classes, in accordance with DepEd Order No. 9, s. 2005, titled “Instituting Measures to Increase Engaged Time on Task and Ensuring Compliance Therewith.” School Heads are advised to make the necessary arrangements to ensure continuity of classes.

11. All teacher participants, school heads, and non-teaching personnel shall register through the official link to facilitate the granting of Vacation Service Credits and Compensatory Time-Off (CTO), pursuant to DepEd Order No. 53, s. 2003, titled “Updated Guidelines on Grant of Vacation Service Credits to Teachers and CTO for Non-Teaching Personnel During Weekends and Holidays.”

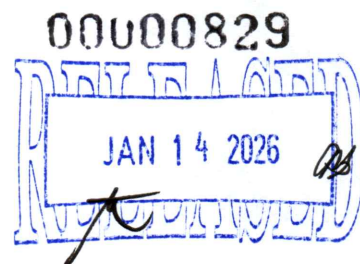

1. Pursuant to the objectives of the Boy Scouts of the Philippines to promote character development, responsible citizenship, leadership, and personal fitness among the youth, the Pampanga Council is pleased to announce the conduct of the **25TH PROVINCIAL SCOUT JAMBOREE** with the theme ***"Be Prepared: Scouts for Peace and Sustainable Development"*** to be held on **15-21 February 2026** at **Floridablanca National Agricultural School - Main Campus, Floridablanca, Pampanga**.
2. **Purpose.** The Jamboree is organized to bring together Scouts from various units and districts in a spirit of unity, friendship, and shared commitment to the ideals of Scouting. It seeks to provide a safe, inclusive, and values-centered environment where Scouts can develop leadership, resilience, and cooperation through outdoor experiences, skills training, and community-oriented activities.
3. **Aim & Objectives.** Anchored on the principle of "Be Prepared," the Jamboree aims to equip young people with the knowledge, skills, and attitudes necessary to actively contribute to peace-building and sustainable development in their communities and beyond. Furthermore, the Jamboree aims to:
  - a. **Strengthen Peace and Brotherhood** by fostering mutual respect, cultural understanding, and cooperation among Scouts, promoting unity and harmony across diverse backgrounds;
  - b. **Promote Sustainable Development Awareness and Action** by engaging Scouts in environmental stewardship, climate responsibility, and community service activities aligned with sustainable development goals;
  - c. **Enhance Preparedness and Life Skills** by developing Scouts' competencies in outdoor living, disaster preparedness, first aid, leadership, and problem-solving;
  - d. **Instill Scouting Values and Citizenship** by reinforcing the Scout Oath and Law as guiding principles for responsible, ethical, and service-oriented citizenship;
  - e. **Empower Youth Leadership** by providing opportunities for Scouts to lead, collaborate, and innovate in addressing peace and sustainability challenges at the local and provincial levels.
4. **Participants.** The following are the general qualifications for the participating Scouts and Scout Leaders, viz:
  - A. Participating **Scouts** must exhibit leadership potential, have sufficient camping experience and:
    - a. Must be currently registered
    - b. Must be physically fit as certified by a licensed physician
    - c. Must be equipped with appropriate camping gears
    - d. Must secure parental or guardian consent



- B. Participating **Scout Leaders** are expected to exhibit maturity, sound judgment, and a clear understanding of their roles and responsibilities in accordance with BSP policies and:

- a. Must be currently registered
- b. Must be of good moral character
- c. Must be physically fit as certified by a licensed physician
- d. Must be equipped with appropriate camping gears
- e. Must hold a valid Safe From Harm Certificate issued by the World Organization of the Scout Movement (WOSM). Access online via: <https://learn.scout.org/resource/sfh-1-safe-harm-essential-learning>

5. **Jamboree Fee.** A registration fee of **Php 500.00 per Participant** shall be collected to cover all operating and administrative expenses, including, but not limited to, program materials, Jamboree kits and souvenirs, and venue rental and utility fees.

6. **Registration Requirements.** Each participating unit shall submit the following to the Council:

- a. Accomplished Jamboree Registration Form
- b. Photocopy of current BSP Registration
- c. Duly signed Parental or Guardian Consent Form (for Scouts)
- d. Medical Certificate or Health Declaration Form
- e. Proof of Payment

7. **Program and Activities.** The Provincial Scout Jamboree will feature the following activities:

- a. Opening and Closing Ceremonies
- b. Inter-District Campcraft and Scouting Skills Competitions
- c. Leadership and Values Formation Sessions
- d. Environmental and Community Service Activities
- e. Cultural and Fellowship Night
- f. Recreational and Team-Building Activities

A detailed program schedule will be issued prior to the jamboree.

8. **Safety, Discipline, and Health Protocols.** All participants shall strictly adhere to the **BSP National Safeguarding Policy at all times**. Designated medical and emergency response teams will be on standby throughout the duration of the event to ensure the health and safety of all participants. Proper camp discipline shall be maintained at all times, and any violation of BSP rules, regulations, and established standards of conduct shall be dealt with through appropriate disciplinary action.

9. **Important Deadlines.** All participating units are enjoined to strictly observe the prescribed deadlines:

- a. **Submission of Requirements** : **2 February 2026**
- b. **Deadline of Payment** : **2 February 2026**
- c. **Final Confirmation of Participants** : **6 February 2026**

10. All District Officers, Institutional Heads, and Unit Leaders are hereby enjoined to extend their utmost cooperation and support to ensure maximum participation of Scouts and Scout Leaders within your respective Scouting districts and institutions.
