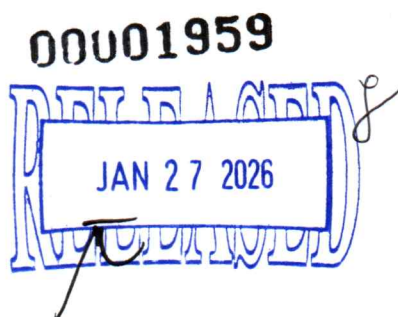

**LEARNER RIGHTS AND PROTECTION STEERING COMMITTEE
FOR THE 2026 PASDAAM**

Members of a public school's Child Protection Committee (SCPC) at the playing venue, or from a school near the venue, may be designated by the Public Schools District Supervisor-in-charge as members of the Venue-Based Learner Rights and Protection (LRP) Steering Committee, from any of the following members of SCPC:

- School Head
- Guidance Designate / Guidance Counselor
- CPC Teacher Representative

NOTE: Only two (2) DepEd personnel shall be assigned per playing venue.

DUTIES AND RESPONSIBILITIES

The Division Learner Rights and Protection (LRP) Steering Committee shall address issues and concerns affecting the rights and protection of learner-athletes before, during, and after the 2026 PASDAAM.

Specifically, the Committee shall perform the following duties:

BEFORE:

- Attend meetings as may be requested by the Division LRP Committee;
- Coordinate with the concerned committees regarding the establishment and operation of the Learner Rights and Protection (LRP) Desk;
- Join the official group chat for coordination and communication through the link or QR code below:

DURING:

- Establish the LRP Desk at the designated playing venue starting **January 28 to January 30, 2026**;
- Coordinate with the Tournament Director regarding the schedule of games;
- Post printed LRP materials in conspicuous areas of the playing venue, accessible through the link below. Materials may be printed as tarpaulin or on bond paper (tarpapel):

- Provide a brief orientation to learner-athletes and adult personnel prior to the start of the games regarding the services offered by the LRP Desk and the Learner-Athlete Safeguarding Guidelines to ensure a safe and learner-friendly

environment for all;

h. Respond to queries and concerns related to Learner Rights and Protection (LRP);

i. Observe and implement the 4Rs of the Child Protection Policy—Recognition of incidents, Recording, Reporting, and Referral mechanisms—in handling and reporting safeguarding concerns;

j. Submit daily incident reports to the Division LRP Steering Committee.

AFTER:

k. Submit a summary of accomplishments and incident reports to the Division LRP Committee.

In relation thereto, the following shall be communicated to the learner-athletes:

1. If a learner-athlete wishes to report a learner protection concern during the 2026 PASDAAM, he or she may approach the Learner Rights and Protection Help Desk located at the playing venue.
2. If a learner-athlete experiences distress or any protection-related concern during the 2026 PASDAAM, he or she may seek assistance from the designated guidance counselor(s) assigned to their respective playing venue.

SERVICES OF THE LRP DESK

The Learner Rights and Protection (LRP) Desk shall provide the following services:

1. Psychological First Aid (PFA);
2. Recreational activities (e.g. Freedom Wall, Photobooth); and
3. Counseling sessions (to be conducted by Registered Guidance Counselors only).
