6. The training schedule and matrix for both the Men's and Women's Volleyball Teams are provided in the attached Training Matrix, which shall be strictly observed by the selected players.



7. All concerned School Heads and Unit Heads are requested to extend full support and cooperation to ensure the successful conduct of the tryouts and subsequent training activities.

B. General Guidelines

b.1 Proper Training Attire

1. All players are required to wear appropriate volleyball training attire, including:
2. Rubber shoes or volleyball shoes
3. Sports jersey or shirt
4. Training shorts or jogging pants
5. Knee pads and other protective gear, as necessary

Improper attire may be grounds for non-participation in training sessions.

b.2 Medical Certification Requirement

All selected players shall submit a Medical Certificate issued by a licensed government physician certifying that they are physically fit to participate in volleyball training and competitions.

- The medical certificate shall be submitted prior to or on the first day of training.
- Players who fail to submit the required medical certification shall not be allowed to participate until compliance is completed.

b.3 Attendance and Discipline

- Attendance in all scheduled training sessions is mandatory.
- Absences without a valid reason may be a ground for disqualification or replacement.
- Proper conduct, discipline, and sportsmanship shall be strictly observed at all times.

b.4 Schedule Adjustments

Training schedules may be modified when necessary, subject to approval by the NEU Volleyball Team Committee, with prior notice to concerned participants.
