Marcos Jr., all concerned teachers and school heads who registered for the said activity are hereby informed that the event has been rescheduled to **February 19, 2026, at 8:00 a.m. onwards**, to be held at the City of San Jose del Monte Sports Complex (near City College of San Jose del Monte).
2. All oath-takers shall wear the **Monday Uniform** along with their **School ID**. Only small bags are allowed inside the venue. Attendees are encouraged to implement carpooling to save resources as well as help with the orderly traffic management and parking concerns in the venue.
3. All attendees are requested to be at the City of San Jose del Monte Sports Complex located at Minuyan Proper, CSJDM (near City College of San Jose del Monte) Drop-off Point on or before 6:00 a.m. for initial security check of the Presidential Security Group (PSG) and QR Code Scanning.
4. Attendees from the Pampanga Cluster are advised to plan their departure time as the trip from NLEX San Fernando Exit to the CSJDM Sports Complex takes at least two and half hours.


