1. School Heads and Teachers play a critical role in ensuring that schools remain safe, inclusive, and legally compliant learning environments. They are often tasked with addressing child protection cases, complaints related to harassment and bullying, and issues that require strict observance of due process.
2. In view of this, the Pampanga Teachers' League Inc. (PTLI) will conduct a **Capacity-Building Seminar on Child Protection, Safe Spaces, and Due Process in Curriculum Implementation for Elementary and Secondary Schools on March 06, 2026**, 8:00am-5:00pm at *City Sanctuary Eastgate Convention Center, City of San Fernando, Pampanga*.


