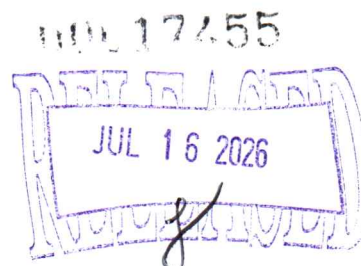

PARENTAL CONSENT AND WAIVER FORM

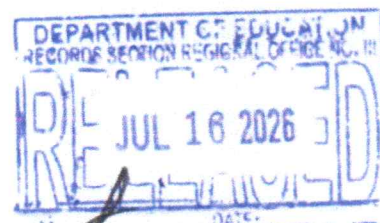

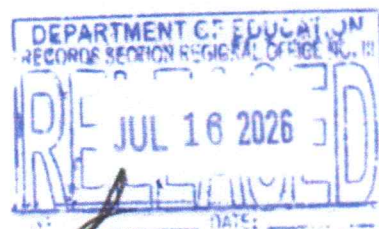
